**Please note:**

Temporary electrical connection will be issued to assist contractors in completing the construction by providing electrical power to operate heating and air conditioning equipment for the purpose of maintaining and controlling environmental air to permit the proper installation of floor and wall covering.

In order for this structure to qualify for conditional power, the following conditions must be met:

1. The structure must be under roof and permanent exterior walls must be in place.
2. Service equipment must be installed and inspected.
3. Personnel must be alerted concerning the presence of energized electrical and heating systems.
4. Heating and Air Conditioning unit must be inspected and approved.

Signatures of approval from electrical, mechanical and plumbing contractors to energize specific portions of their systems (see above).

**CONDITIONS FOR MAINTAINING CONDITIONAL POWER ARE AS FOLLOWS:**

1. Conditional power is granted for a period sixty days.
2. Conditional power is intended for operation of environmental systems. No connections for branch circuits or any other service for temporary use is permitted unless approved by the Electrical Inspector.
3. The structure shall not be occupied until all final inspections have been approved, all fees paid and certificate of occupancy has been issued.
4. Conditional power is to be in the name of the Responsible Agent.
5. Energized systems to be maintained in a safe and secure manner.
